4. PURPOSES AND LEGAL BASIS

All third parties are bound by confidentiality obligations and only process data on our instructions.

As we operate internationally, your data may be transferred outside the European Economic Area (EEA), including to countries with an adequate level of data protection. Where required, we implement appropriate safeguards to ensure your data remains protected.
